
No Discrimination Against Persons or Groups

- The freedom to run the program as you wish, for any purpose (freedom 0).
- The freedom to study how the program works, and change it so it does your computing as you wish (freedom 1).
- The freedom to redistribute copies so you can help others (freedom 2).
- The freedom to distribute copies of your modified versions to others (freedom 3).

"No Apartheid" license

A version of the Berkeley License prohibits use by "the police or security forces of South Africa"

ANC, Africans Rule SA

The police of South Africa now work for a democratic, multiracial government. But the license would still prohibit them, if used.

Does it have to have a UI? An API? What about mobile?





Discrimination Free

- Discrimination clauses are Usage Restrictions
- Usage restrictions are incompatible with
 User Freedom
- They also create major legal and practical problems for software developers
